UPDATING OUR CLUB'S CONSTITUTION - Special General Meeting at our 7 October 2025 meeting

In an email message sent on 9 September members were informed of a Special General Meeting on 7 October 2025 to update and modernise our club's constitution and standing resolutions. The proposed constitution and proposed standing resolutions are in a format as recommended by Probus South Pacific (PSPL). Other Probus clubs have either adopting them or are in the process of adoption.

Our club's current Constitution provides at section 3.9 of the By-Laws that to adopt the new constitution by special resolution, 75% of members present and any proxies will need to vote in favour of adoption. Adoption of the standing resolutions similarly requires a 75% vote in favour.

If the club votes in favour of the motions as listed below, the next step is to apply to the Office of Fair Trading (OFT) for the new constitution and standing resolutions to be approved and registered. Once that occurs, they then become effective. PSPL has advised that OFT has pre-approved the wording of the proposed constitution and of the proposed standing orders.

If you perhaps will not be at the meeting, a proxy form is available from club secretary, Ross Berghofer. Proxies must be received prior to the commencement of the special general meeting.

What follows is the wording of the email message of 9 September, that included the motions to be put the meeting, together with the current and proposed documents as attachments. Those attachments are not included with this Newslettter.

"Our club's constitution needs to be updated, in particular to meet the requirements of the Office of Fair Trading and other legislative requirements.

PSPL has supplied a recommended constitution that has been approved by the Office of Fair Trading. The constitution as recommended by PSPL has been reviewed by Sam, Alison, and Ross, and then submitted to the committee for discussion. The committee agreed to recommend to the meeting that the new constitution be adopted.

In essence the new constitution updates our existing constitution. By-laws are now called Standing Resolutions; Part A of the Standing Resolutions is customised to suit our club's requirements. Part B refers to other matters that can be considered later on. The recommended constitution and standing resolutions for approval at the October club meeting were included in the email message.

The main advantages of the new constitution, if approved, are:

- * the removal of outdated and discriminatory language throughout the document;
- * no two sponsors need to sign an application for membership;
- * the Standing Resolutions are customised to suit our requirements;
- * the day to day operations of the club are specifically identified in the Standing Resolutions and removed from constitution;
- * mandatory meeting attendance requirements have been removed;
- * term of office is no longer restricted to two years;

* a new committee takes effect immediately after the AGM, not on 1 April as is now.

Consequently, notice is hereby given to all members of the following proposed motions; the resolution to be put to club members at our 7 October 2025 meeting is:

- a. That members, by special resolution, hereby adopt the attached recommended constitution provided by Probus South Pacific Limited replacing the current Constitution of the Club.
- b. That members hereby adopt the attached Standing Resolutions replacing the current By-laws of the club."

The Hydro Majestic hotel, located in Medlow Bath, is renowned for its historical significance as one of Australia's pioneering health resorts.
