COMMITTEE MEETING 2nd June

Probus recommended Constitution and Standing Resolutions

Probus management realised that the current constitution for Clubs needed updating. So, in 2023 they commenced a review with the aim of providing clubs with an updated, concise constitution that reflects modern practice and current legal requirements. The recommended constitution was sent to the relevant regulators in every State and Territory of Australia and

could only be sent to clubs when approval was received from all of the regulatory bodies.

The new Recommended Constitution provides greater flexibility for clubs to manage their internal affairs by way of Standing Resolutions.

Your committee has discussed the Standing Resolutions required to conduct the affairs of the club, and recommend Standing Resolutions numbers 1-28 to you. One of the benefits is that the current restricted terms of office of one year for the President and three years for all other offices have been removed. This has been replaced by SR 3 which states that terms of office are unlimited.

The current Management Committee members recommend that you should vote YES for both the NEW CONSTITUTION and the STANDING RESOLUTIONS which have been circulated to members.

Finance report We ended May with \$12257.54 in the bank having income of \$3555 and expenditure of \$2042. Our balance includes several thousand that members have paid for future activities including \$2200 tour deposits.

Membership report We currently have 100 members including four who will be inducted on 26th June. We welcome Frances and Joe De Andrade plus Eva Tarnok as new members.

We also have two potential members on the waiting list.
